**NARRATIVE**

On 10/19/2016 Detective Erickson was leaving the emergency services building in his assigned department vehicle. Erickson observed a passenger vehicle bearing Texas plate #BRN8327 traveling directly in front of him. Erickson does not have a mobile data terminal in his vehicle so he requested dispatch run a registration check on the vehicle. Erickson followed the vehicle as it turned southbound onto Highway 93 South. Dispatch informed Erickson that the registration on the vehicle was currently expired. Erickson activated his emergency lights in an attempt to make a traffic stop, the vehicle yielded to the side of the road in the vicinity of the Hampton Inn.

Erickson exited his vehicle and made contact with the driver of the vehicle, Erickson identified himself as a detective with the Whitefish Police Department and the reason for the traffic stop. Erickson immediately observed that the driver would only lower his window approximately one inch, making any form of verbal communication very difficult. Erickson again advised the driver of the reason for the stop and requested his driver's license, registration, and proof of insurance. Erickson observed that the male driver later identified by his Nevada driver's license as Brooks Allen Weeks would only slightly turn his head in Erickson's direction and mumble a few words. Erickson asked Brooks if he

could please lower his window so they could converse as there was an extreme amount of traffic noise along the Highway. Making any form of verbal communication difficult and almost impossible with the window only being cracked. Weeks motioned to Erickson that he would not roll down his window by shaking his head from side to side indicating to Erickson that he was not willing to do this. Erickson continued to explain the reasoning for the traffic stop and asked on several occasions for Brooks to produce some form of identification to identify himself. Erickson was professional in communicating with Brooks and advised him of the law in Montana and that he was required to have a valid registration on his vehicle as well as produce some form of identification.

During the time Erickson was attempting to communicate with Brooks, Erickson observed a female in the passenger seat latter identified as Candi Lee Weeks. Erickson also observed a male in the rear passenger seat directly behind the drives seat. Candi advised Erickson that they were just "traveling" and did not have to have valid registration or produce any form of identification. Erickson advised Candi that driving in Montana was a privilege and not a right and with that privilege a valid driver's license would need to be produced by Brooks. Candi advised Erickson that they were "traveling" and you do not need a valid driver's license to travel. Again, communication with Candi was very difficult as the window on the driver's side was only cracked approximately one inch and the traffic noise at this time of day was heavy. Erickson again requested that they lower the window in an attempt to make the process and communication between all parties better. Again, the Weeks refused to lower the window to help in the communication process. At this point, Candi began to write something down on a piece of paper, Candi presented the paper to Erickson which she had written her personal information on. Erickson thanked Candi for the information but again advised her and Brooks that Brooks was currently in physical control of the vehicle and he needed his information. Again, Erickson asked Brooks for some form of identification, Brooks continued to look straight ahead and shook his head from side to side indicating to Erickson that he was not going to produce any form of identification. Erickson advised Brooks numerous times that if he did not produce any form of identification that he would be placed under arrest and that they would use whatever means necessary to remove him from the vehicle.

Erickson at this time advised Brooks that if he did not produce any form of identification he would be arrested for obstruction of justice, Brooks did not respond to Erickson. Erickson attempted to open the driver's door and found that it was locked. Chief Dial was present during the whole conversation with Brooks and Erickson advised Dial that Brooks would not produce any form of identification, roll down the window, or exit the vehicle. Erickson advised Dial that the drives side door was locked as well. Dial returned to his patrol vehicle and retrieved a flashlight, Dial attempted to break out the rear passenger side window by striking it two to three times with the flashlight with negative results. At this point, a tow truck which was requested arrived on scene and backed up directly in front of the Weeks's vehicle.

Erickson again made contact with Brooks at the driver's side door and Brooks indicated that he was willing at this point to provide Erickson with his identification. Brooks was not able to produce a tangible identification but verbally advised Erickson on his name, date of birth, and state of which his driver's license was out of. Erickson had Officer Stahlberg contact dispatch with this information, Officer Stahlberg advised Erickson that Brooks had a valid driver's license out of Nevada. Erickson instructed Officer Stahlberg to issue Brooks a citation for operating a vehicle with expired registration.

Erickson thanked Brooks for providing his identification and advised him that he would be getting a citation for expired registration and then would be on his way. Erickson also advised Brooks that this whole process could have been avoided if Brooks would have produced his identification when first asked by Erickson. Erickson then issued Brooks his citation and advised him that he was free to leave.
