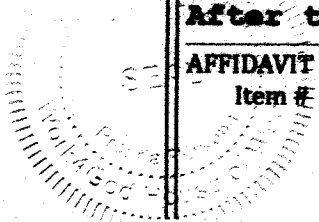

**Me:**I object!

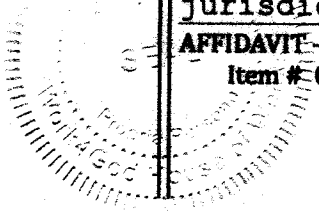
The judge with a threatening expression tells me not to over speak her!

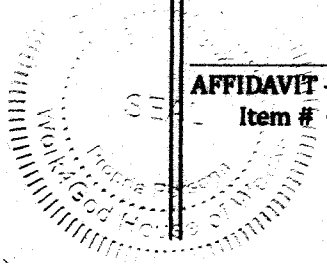
**Judge; Denied**
