Judge: Would you spell your last NAME?

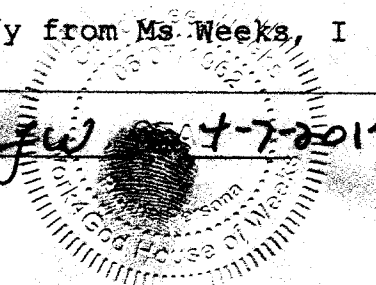
Candi: W-e-e-k-s

**Judge:** Underlying citation E-13967

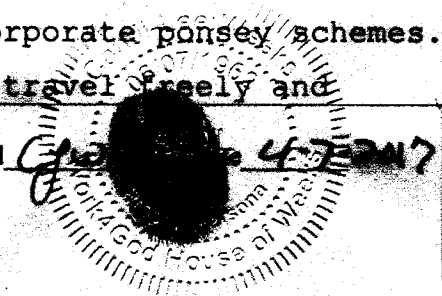
