3. I demand that you produce the name, badge number, and identification for the Arresting/Detaining Officers, in these matters for booking numbers E13967, E17634, E15366
4. I demand that you produce the name, badge identifier, of the Person (or Officer) who slammed an object into our family cars window 4 times deafening a family member and scratching/chipping the window..
5. I demand that you produce the oath or affirmation for the above identified Persons or Officers, as required by Montana Admin Rule 23-13-203, and to supply Oath of Office Montana Art III sec3 Oath of Office before entering upon the duties of their respective offices.
6. I demand that you provide proof of agency relationship for all officers or individuals involved, certifying their employment or active relationship with the Whitefish City police or State Department, during all times relevant regarding the arrest and confiscation of property in the matter of the bookings number E13967, E17634, E15366.
