I, Candi-Lee:Weeks A living Man/Woman, and one of the people, in this court of record 28 U.S. Code § 132 (a) **Claim & Declare:**

There are 3 separate auto detainment incidents:

On September 29, 2016 at approx 2:00 am Officer Kevin Conway around Whitefish Montana-state detained the family of Candi-Lee:Weeks in their auto on public road 93, and issued them a ticket.

On October 19th, 2016 Shane Erickson in an unmarked truck, and Bill Dial detained the Weeks family while coming directly from the Whitefish courthouse in their family auto. Detained on public road 93 Whitefish, Montana-state, and was issued another ticket.

On November 16th 2016 Officer Bridger Kelch, Chase Garner, Shane Erickson, detained Plaintiffs family while coming directly

3. removed Plaintiff and family from the auto. Detained at Pin and Q
4. parking Lot Whitefish Montana-state.

6. On **November 16th and 17th** Hills Brothers agent took
7. plaintiffs auto from the Pin and Q parking lot Whitefish Montana-
8. state and held it for ransom. Hills Brothers towing would not
9. release auto unless it was towed from Whitefish. Hills Brothers
and agents Bill Hill held auto for ransom.

11. **November 16th 2016** at the Whitefish Municipal
12. courthouse/police department Judge Bradley F Johnson suggested a
13. \$500 bond and Prosecutor Kristi Curtis acting in collusion agreed
14. to the \$500 bond during a mandatory hearing. Chase Garner police
15. officer made direct threat of arrest if Plaintiff did not pay for
16. bond and refused to allow plaintiff to leave building. Chase
17. Garner stood watch over plaintiff. Chase Garner told Plaintiff
18. that she could not drive a vehicle, Plaintiff signed Bond under
duress, with Brian Carters full knowledge and agreement.

19. On **September 29th, 2016** Plaintiff was under duress and
20. threat of arrest by Kevin Conway, Judge Bradley Johnson, and
21. Kristy Curtis forced to appear on **October 12, 2016, October 19th,**
22. **2016, November 16th, 2016, November 30th, 2016, December 7th,**
23. **2016, December 14th, 2016, and December 16th.**

24. Bradley F Johnson told Bondsman that Plaintiff did not
25. appear on **December 16th, 2016** in which she claims she did appear
26. and plaintiff claims that she was there with her filed Notice of
27. appearance and the recorded audio of the courtroom on **December**
16th, 2016.


