Candi: Are you detaining me?


Officer Conway: Yes

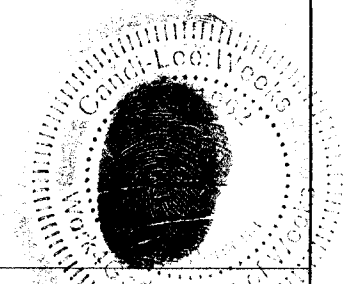

Candi: I do not drive, I only travel.

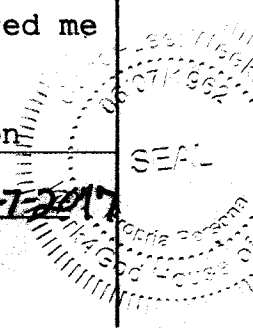
Officer Conway proceeds to crack jokes about traveling and mock me.
