which we did immediately.

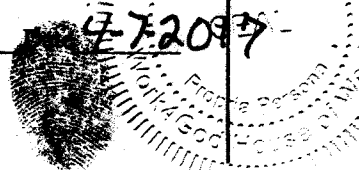
A man in plain clothes comes up to the window and demands

30. **answer.**

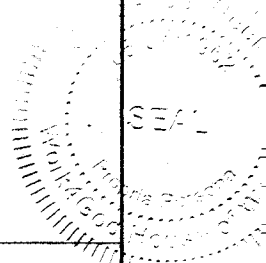
31. **Bill Dial** then proceeded to **smash** this object into the **rear**
