On October 26th at approx 11:09 am, I contacted the
Whitefish Courthouse to request an emergency extension of my 3rd
demanded appearance by the Whitefish Court judge Bradley F
Johnson The need for this request was due to a flat tire on my
family auto.

I was informed by Shelly City Clerk that they only accept
the request by fax, personal appearance, or mail and per their
rules they need 10 day notice. I explained to Shelly that I do
not have a fax nor personal mailbox and due to the bad tire could
not appear this day. I offered that I could e-mail this request
as the flat tire does not afford me the opportunity to send mail
via postal Annex or appear in Propria Persona. Also a huge issue,
I was never afforded 10 days as my demand for appearance gave me
only 7 days which would make my request all but impossible. I was
informed via Shelly/Whitefish city clerk that the Court does not
have an e-mail address to send request to.

I requested Shelly explain this situation with the judge
Bradley F Johnson whom demanded my appearance by threat of

5. a fax machine. The Oct 26, 2016 my family auto had no air in one

7. the 10 days to comply with Whitefish courthouse rules for
8. requesting an extension of my appearance was not afforded Candi L
9. Weeks.

10. Candi L Weeks was given only 7 days which would never give
11. opportunity for an appearance extension containing the Whitefish
12. court 10 day rule.

13. Wherefore, I Candi L Weeks Motioned Whitefish court for the
14. proper 10 days needed per the Whitefish Courthouse rules for my
15. court date extension in order for me to comply with their own
16. rules and I was denied by the rule makers due process.
