PA: ... That's what my proposal was.

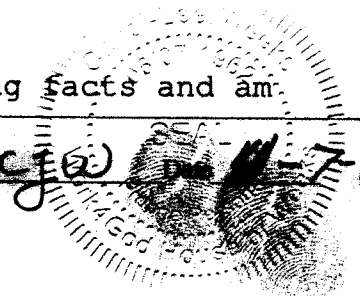
Judge: Would you leave the seat please. we'll see to other people first
