I, Colton:Weeks , A living Man/Woman, in this court of
record **Claim & Declare:**

The events that follow took place on the 19th of October,
shortly after leaving the Whitefish courthouse with my mother and
father. My mother had a court date there, and it was but one of
several that were the result of the judge telling my mother to
"Come back next Wednesday". And, without fail, the judge once
more told her to "Come back next Wednesday at 1:30".

We departed the courthouse, and were pulled over, in front
of the Pin and Cue. **Detective Erickson**, the officer who pulled us
over, as well as several of his many comrades, had been at the
courthouse at the same time as we had. We had seen them there. It
was all too obvious that we had been purposely followed, and
stalked, by the Whitefish police department.

My father had been traveling at this time, and **Detective
Erickson** aimed his questions at him.

According to **Detective Erickson**, his reason for stopping us
was the expired registration. Which, was due to the fact that we
had just bought the car, and had temporarily left the old plates

2. on. All in all, I would call it a thin disguise for stalking us.

3. **Detective Erickson** was very insistent to have my fathers ID.
4. Seeing as he had none, he informed them that he could not comply.

5. **Detective Erickson** then told us that the situation would get
6. violent if we did not comply. In the background, I saw a
7. multitude of **police officers brandishing multiple weapons,**
8. including large canisters of **bear spray.** One of his colleagues
9. then **approached with a club and shouted that he was going to**
10. **break open the window and drag us out of the auto.**

11. This **crazed officer Bill Dial** continued to shout some more
12. threats, and then ended his tirade with "**You had better cover**
13. **your eyes, or I'll get glass in them!**". He walked over to the
14. rear right window, and **hammered the window four times,** hard
15. enough to chip the glass.

16. The worst damage done by **Bill Dials** hammering on the window
17. was the damage to my ears. My right ear, in particular. I was
18. sitting very close to the window, due to my being in the rear of
19. the car. When he did that, I experienced immediate piercing pain
20. in my ears, and after a while, it faded to a constant dull
21. ringing that **lasted the rest of the week.**

22. It was after that that the details grow less clear to me, as
23. I was too distracted by the pain in my head as well as the **trauma**
24. of the experience in general.

25. After this happened, after lots of threats, and a towing
26. company preparing to tow the car away after the windows were
27. going to be smashed open and the human occupants dragged out, my
28. father gave **Detective Erickson** his name and birth date to
29. identify himself. This seemed to satisfy **Erickson,** as the
30. officers stopped their assault on our family auto.

31. We were written up a ticket, and Detective Erickson sent us on
32. our way. That, was perhaps one of the most traumatic experiences
33. of my life. For the first few weeks after the incident, I was

Some nights **I cannot sleep** after waking up from a nightmare about this Crazy officer smashing our auto and dragging us out of our family auto and spraying bear spray in my eyes..then I wake up...
