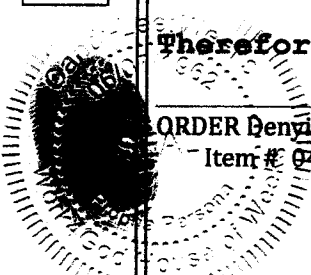



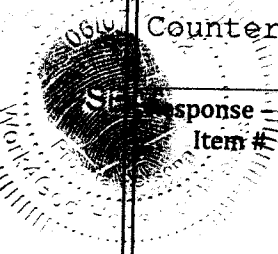
CounterPlaintiff chooses not to address **Document 28**, because it has been denied by the Tribunal.

5. **Document 26 > Page 2. > A Paragraph 1.** BRIAN CARTER sates
6. that: "**Plaintiff called Moonlighting Bail Bonds at its office in**
7. **Kalispell, Montana, on November 16, 2016..**" this is incorrect,
8. because the CounterPlaintiff never called on November 16, 2016.
9. "The Whitefish Municipal Court" called "Moonlighting Bail Bonds"
10. on November 16th, 2016, and requested their services for Candi-
11. Lee:Weeks without her consent or knowledge. Prior to the arrival
12. of BRIAN CARTER, "Moonlighting Bail Bonds" confessed to
13. Brooke:Weeks, that "Moonlighting Bail Bonds" was on the way,
14. because they had be summoned by "The Whitefish Municipal Court".
15. Plaintiff paid \$125 under duress (see CounterPlaintiff's
16. Affidavits & Declarations).
